25 Section 2. All matters and proposals pending in Standing Committees prior to  
26 passage of this Resolution are hereby referred to the appropriate Standing Committees  
27 created by this Resolution.

29 Section 3. Each Committee established hereunder shall operate in accordance  
30 with Council Resolution No. R2000-176 as amended, "Rules for the Council's Standing  
31 and Select Committees".

33 Section 4. The terms of each of these appointments shall be for the remainder of  
34 the calendar year 2007, or until a replacement is appointed by Resolution of the  
35 Council.

2 Exhibit to all Councilmembers and Council Staff, the County Executive, and all Pierce  
3 County Departments and Agencies.
