Title 19 PCC was repealed in its entirety by Ordinance 94-82S § 1, 1994.

The Gig Harbor Community Comprehensive Plan was readopted by Ordinance 94-82S § 3 (part), 1994, and codified as PCC 19B.170.010.

The Gig Harbor Community Comprehensive Plan was subsequently moved and recodified as PCC Chapter 19B.10 by Ordinance 96-111 §§ 2, 7 (part), 1996.

The Gig Harbor Community Comprehensive Plan was repealed in its entirety by Ordinance 2001-44s2 § 1, 2001, and readopted as the Gig Harbor Peninsula Community Plan by Ordinance 2001-44s2 § 2, 2001.

The Gig Harbor Peninsula Community Plan was amended by Ordinance 2004-87s § 9, 2004.

The Parkland Spanaway Comprehensive Plan was repealed in its entirety by Ordinance 2002-21s § 1, 2002, and readopted as the Parkland-Spanaway-Midland Communities Plan by Ordinance 2002-21s § 2, 2002.
