Voter Registration Deadlines

The deadline to register to vote in Pierce County is Monday, January 11, 2010. You must be registered or have transferred your registration by January 11, 2010, to be eligible to vote in this election.

A special in-person late registration period is available for people who are not registered to vote in Washington State. Monday, February 1, 2010, is the last day to register at the Election Center to be eligible for the February 9, 2010 Election.

Voter registration and voting assistance is available. Accessible voting units will be available beginning on Wednesday, January 20, 2010 from 8:30 a.m. to 4:30 p.m. Monday - Friday through Election Day. Election Day hours are 7:00 a.m. to 8:00 p.m.
