Updates and Corrections to the Online Map

December 2009

Grid Map 1 The scheduled extension of the Cushman Trail from 96th Street NW to Borgen Boulevard in Gig Harbor was removed. 96th Street NW was labeled.

Grid Map 2 The new section of the Cushman Trail from Grandview Street to Rosedale Street NW in Gig Harbor was added. The location of the trailhead on Grandview Street was added. 96th Street NW was labeled.

Grid Map 4 The new bike lanes on S. 12th Street from S. Union Avenue to S. Sprague Avenue in Tacoma were added.

The new bike lanes on N. 21st Street from N. Proctor Street to N. Alder Street in Tacoma were added.

The new bike lanes on N. 30th Street from N. Proctor Street to N. Alder Street in Tacoma were added.

The new bike lanes on 40th Street W from Olympic Boulevard W to Sunset Drive W in University Place were added.

The scheduled bike lanes on N. 37th Street in Tacoma were removed. North Shirley Street (from N. 35th Street to N. 37th Street) and N. 35th Street (from N. Shirley Street to N. Orchard Avenue) was added as alternate bikeways.

Pacific Avenue (from S. 15th Street to S. 11th Street) and S. 11th Street (from Pacific Avenue to the E. Dock Street overcrossing) was added as bikeways.

E. 15th Street, St. Paul Avenue, and Portland Avenue was labeled.
