 - Fed LB LOWER 3 MILES THROUGH PORT
 - Fed RB
 - North Levee Rd 8 MILES UP TO MERIDIAN
 - River Road
 - River Road Extension LEFT BANK UPSTREAM OF MERIDIAN
 - Riverwalk "FLASH CUBE BUILDING AREA"
 - Mid Puyallup
 - Highway 410 RIGHT BANK BEHIND APARTMENTS PROJECT HAS BEEN INCREASED TO FULL 100-YEAR LOS AT COUNTY'S REQUEST (LOCALLY PREFERRED PLAN)
 - Upper Puyallup
 - Jones Setback PROJECT CHANGED TO SETBACK LEVEE AT REQUEST OF PUYALLUP TRIBE - *NOT* A LOCALLY PREFERED PLAN – TURNED OUT ENVIRONMENTAL BENEFITS OF SETBACK OFF SET MITIGATION COSTS FOR OTHER PROJECTS
 - Did not include any improvements on the White River
- National Economic Development (NED) Optimization done, 2017
 - Found errors in earlier work
 - White River "Sumner Commercial Levee" added back into TSP
 - 1+ MILE OF LEVEE ON RIGHT BANK (ACROSS FROM GOLF COURSE) TO PROTECT WAREHOUSING DISTRICT
 - ECONOMICS ALLOW FOR HIGHER LEVEL OF SERVICE (ADDITIONAL FREEBOARD ABOVE 100-YEAR FLOOD)
- BENEFIT COST RATIO FOR ALL RECOMMENDED ACTIONS: 1.7:1

Consequences of adding a project late in the process:

- Much of the work completed for the TSP needs to be updated
 - Environmental Review
 - Cultural Assessment

 - Overall benefit-cost ratio FINAL BCR DEPENDANT ON OUTCOME OF PENDING WORK UPDATING THE NED (AGAIN!) WILL ESSENTIALLY BE FINAL WORK PRODUCT

Impact to schedule and budget:

- Seattle District staff estimate: \$2 million additional over two years
- Corps HQ has requested a revised proposal no more than \$1 million additional in less than one year

Factors affecting decision:

- County desires a "policy compliant study" NECESSARY FOR STUDY TO HAVE VALUE WHEN COMPETING FOR FEDERAL DESIGN/CONSTRUCTION FUNDING
- This requires a "certified cost estimate" CERTAIN LEVEL OF WORK/JUST CAN'T CUT SOME CORNERS...
- Possible to request a "policy waiver" to finalize study with less than 35% feasibility-level design
 - Would result in additional scrutiny during review phase
 - Could increase "contingencies" to point that project no longer has a competitive benefit-cost ratio
- Seattle District staff also believe a policy waiver would be needed for the real estate work –
 WITH A FORMAL POLICY WAIVER, STUDY WOULD STILL BE DEEMED "POLICY COMPLIANT"
- HQ may be open to negotiating on both budget and schedule (\$1.7M? 18 months?)

Next Steps:

 - o Required for any extension beyond currently approved schedule and budget
 - o Will need to include a "No Action" alternative, i.e. terminate the study

- Timing of this meeting is still uncertain ORIGINALLY EXPECTED IT TO HAPPEN IN OCTOBER, THEN EARLY JANUARY. SEATTLE DISTRICT STAFF NOW JUST SAYING "WE'RE NOT ABLE TO INFLUENCE THIS PROCESS"

WELCOME: Meeting officially called to order at 5:33 p.m.

SUMMARY: The summary notes from November 16, 2017 meeting were approved.

UPDATES AND COMMENTS:

Council Briefing- Hugh Taylor

Executive's office put out a press release of the 2018 budget, focusing on behavioral health, public safety, and parks. There was a 6% increase in the budget from 2017. Council retreat is next month to discuss the 2019 budget.

Discussion with board members: The venue to communicate with Council has been lost. The department gives recommendations to Council. The Performance Audit Committee voted to accept the rate study, but the Executive does the budget.

Bonding issue: Facilitate a presentation to EIDC and setup a dialogue with the Executive. Timing is critical; the dialogue needs to happen by April or May. Hugh is encouraged to hear that this board wants to be more involved. Council is open to more dialogue with the board and Hugh will work to arrange that.

Surface Water Management Update- Melissa McFadden

Our director is asking for a financial plan for SWM.

Water Quality Manager interviews were last week with final interviews tomorrow.

We have a new tribal relations manager – Sarah Colleen Sotomish.

We have a direction team for the new NPDES permit.

We received an admin order from DOE in late November for notice of violation for code updates making LID a requirement.

Dennis Hanberg, PPW Director, is asking us to work on messaging of the important things we do:

- Costs of clean up of river properties because of the homeless.
- Inspection group and what they do.

- Send out success stories.
- How can we help promote development.
- SWM fee rural vs urban.
- Farm credit
- Charging JBLM a SWM fee.

Mike S: We need a sustainable solution for funding for the utility.

We need to look for other ways to inform the Council and Exec on capital projects, NPDES requirements and costs. More messaging and selling the value of the SWM Utility – is there a way to link the SWM Utility with other services. We need to educate Citizens on clean water. SWM needs to communicate this to the Exec.

FCZD BUDGET: Anne-marie Marshall-Dody

Anne-marie gave a briefing on the 2018 budget.

PUYALLUP RIVER GENERAL INVESTIGATION: Harold Smelt

Harold gave a briefing on the GI investigation. See handout.
